Per NRS 489.801 (2) It is unlawful for any person knowingly to sell or offer for sale any manufactured home which has been constructed on or after **June 15, 1976**, unless the manufactured home and its components and systems have been constructed and assembled according to the standards prescribed pursuant to the National Manufactured Housing Construction and Safety Standards Act of 1974 (42 USC 5401).
